# The democratic structure of IFA ensures that members of our county executives have a say in electing our regional chairs.

With a number of critical issues on the horizon for Irish farming, it's very important to have strong IFA leadership to represent the interests of farm families.

Two candidates are running for the position of IFA Ulster/North Leinster Regional Chair – Maurice Brady and Kevin Sweeney.

#### **Ulster/Nth Leinster Chair Role**

- Communicating with and supporting County Executives between Council meetings;
- Co-ordinating IFA campaigns at a regional level; and,

- Protection of CAP Payments with a continued ring fence of Pillar 1 & Pillar 2 which is vital for this region.

In 2010, we shifted to beef and sheep only, This became unsustainable and I began working in the live export industry, forming strong relationships with farmers. We now rear turkeys along with milking 100 cows, rearing dairy-beef calves and zwartble sheep.

### How the vote works



All members of the seven County Executives in the Ulster/Nth Leinster region are entitled to vote by secret ballot. This includes county officers, national committees/sections and Council representatives, two Macra representatives and up to four delegates per Branch.

Branch delegates will have a strong influence on the result. This is because at each County Executive meeting, the delegates' votes from each Branch will be placed in a branch envelope. These branch votes are weighted to reflect the membership of the branch.

A branch membership of:			
8-25 members	26 -50 members	Every extra 25 members or part thereof	
= 1 vote	= 2 votes	= one additional vote	

This means a branch with a membership of 60, and with four delegates at the County Executive meeting, would have 12 (4x3) weighted votes in the Regional Chair election. The election count will be held in the Irish Farm Centre, Tues, 2nd Dec, 2025.
